Plan Principles

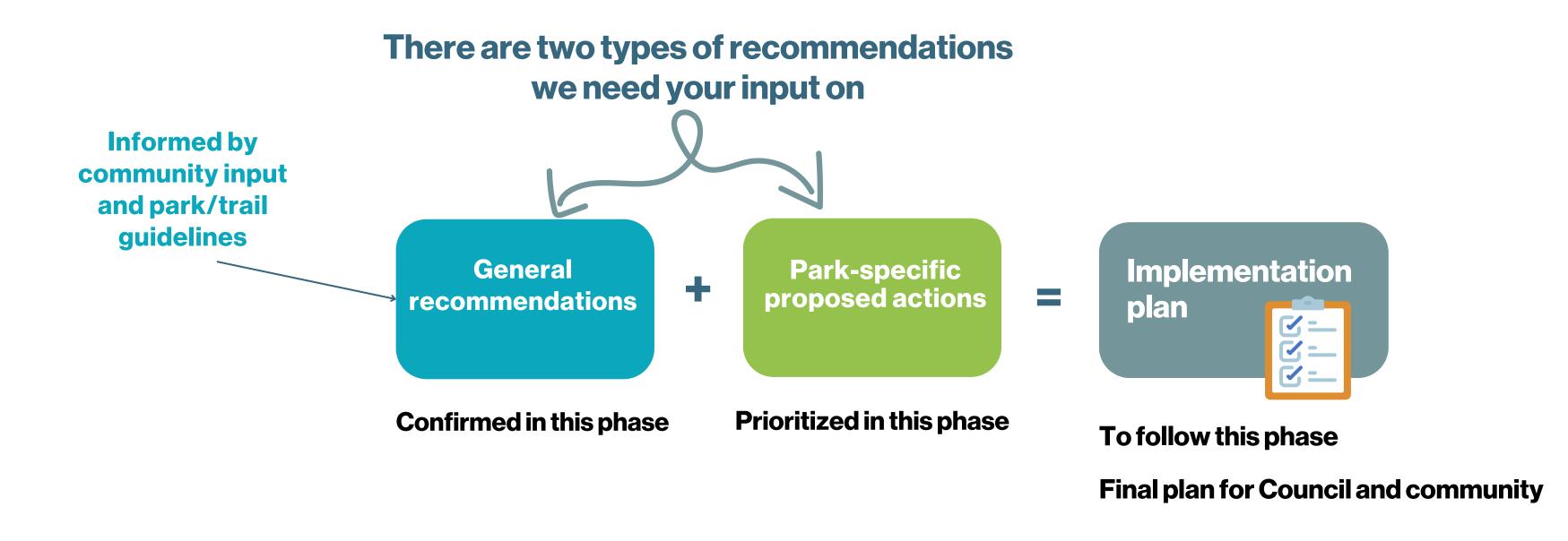
The following plan principles are the core considerations behind the draft plan's goals and actions. These support the objectives of our Official Community Plan.

- Ensure the parks and trails system is welcoming, inclusive, diverse and equitably distributed.
- Foster **connectivity** for people, places and nature.
- Celebrate, protect and enhance our natural character and environment.
- Manage and operate the parks and trails system in a way that is **collaborative**, **climate adaptive**, **future-forward** and **cost-efficient**.

Community Park	Large, central destination parks . Appeal to the broad community as well as to visitors and include a diverse collection of features and facilities. Neighbourhood Park	Respond to localized recreation needs of residents within walking distance to their homes. Provide a visual, physical and social focus for a neighbourhood area. Nature Park	Dedicated for community access to nature and can provide ecological conservation , wildlife habitat protection , watercourse protection. Undeveloped Park	Areas dedicated as park land but undeveloped and lacking identification, maintenance, access or amenities; or are inaccessible. Most often not suitable, known or used by the community as public park space.	To allow public access to the District's foreshore with the purpose of maximizing the recreational potential of the shoreline. May provide physical or visual access.
Shoreline Access	To allow public access to beaches with the purpose of maximizing the recreational potential of the shoreline. May provide physical or visual access.	Benches or seating areas, bike racks, signage to minimize conflicts with adjacent landowners.

About our parks

The BC Parks and Recreation Association reviewed all municipalities in BC and found the average parkland-to-resident ratio is 2.51 hectares/1,000 residents.

Currently, the District boasts a ratio of 4.98 ha (12.3 acres)/1,000 residents.

Furthermore, when including regional and provincial parkland and open spaces, the ratio increases to 14.52 ha/1,000 residents.

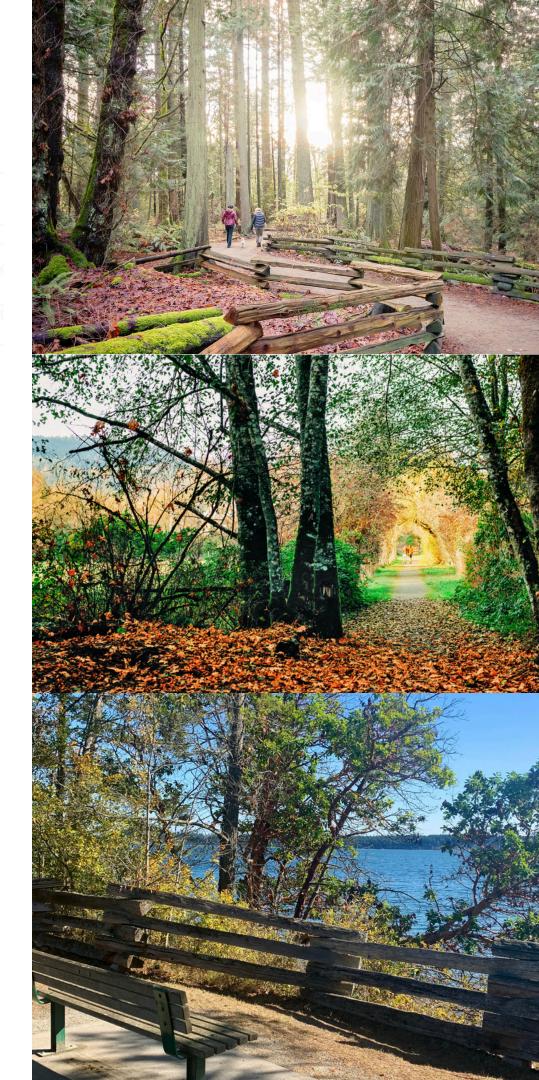

Proposed Actions

- 1. Ensure large, busy parks have public transit access, accessible parking, washrooms, picnic areas, and seating.
- 2. Continue offering accessible play opportunities.
- 3. Provide accessibility ratings on signage at trailheads and along trails.
- 4. Develop online resources and maps with accessibility features.
- 5. Add rest stops along trails and at viewpoints.
- 6. Upgrade paths and trails to meet updated standards.

 Newman Farm Beach Access
- 2. Shoreline Saanichton Bay Park, Island View Beach
- 3. Forest Centennial Park
- 4. Farm Newman Farm Middle Parcel

Signage & Wayfinding

Ensuring that visitors to the districts parks system can navigate effectively.



- Sign major trail connections in parks and along active transportation routes.
- 2. Add interpretive signage on local biodiversity, ecosystems, WSÁNEĆ history, and SENĆOŦEN language.
- 3. Provide signs about responsible park usage to reduce user conflict and protect ecosystems.
- 4. Improve maps, brochures, and online resources for park and trail users.
- 5. Create self-guided trails connecting parks, businesses, and points of interest.
- 6. Add and maintain signage at water access points; consider shoreline markers for water users.
- 7. Continue implementing the District's Wayfinding Strategy.



Trail Connectivity

Acquiring and developing trail connections that foster connectivity for people, places and nature.



Proposed Actions

- 1. Upgrade trails to meet classification standards.
- 2. Ensure popular trails are wide enough for all users and large groups, with passing zones.
- 3. Connect or reroute trail networks across parks to create destination trails of varying lengths and difficulty.
- 4. Develop a district-wide trail network to close gaps and improve major east/west and north/south connections.
- 5. Explore trail development in underserved areas like the Keating Business District and Tanner Ridge.
- 6. Collaborate with Central Saanich and CRD to plan major trail networks for regional transportation, recreation, and tourism.

Children & Youth Amenities

Ensuring that visitors to the districts parks system can navigate effectively.



- Ensure a playground within a 10minute walk of all residences in the Urban Containment Boundary.
- 2. Replace playgrounds as part of asset management, considering:
 - a. Adding natural play elements.
 - b. Offering inclusive and accessible play.
 - c. Including options for preschool and school-age children.
- 3. Encourage partnerships or sponsorship for playground replacement.
- 4. Develop new youth/teen amenities like a bike skills park, pump track, or sport courts near schools, transit, or areas with more youth and families.



Facilities & Sports Courts

Creating multi-court sport facilities and improvements to existing sport facilities.



Proposed Actions

- 1. Collaborate with Peninsula
 Recreation Commission on
 peninsula-wide amenity planning
 and explore space for underserved
 sports.
- 2. Improve sports fields and ball diamonds to enhance use, extend seasons, and improve accessibility.
- 3. Prioritize multi-use courts in parks to maximize space, encourage diverse activities, and create inclusive experiences.
- 4. Integrate multi-court facilities with seating and additional activities.
- 5. Add washrooms in high-use parks, considering portable toilets where servicing is unavailable.

Shoreline Accesses

Improve access to beaches and shorelines



- 1. Upgrade beach access stairs with safety features like railings.
- 2. Enhance non-motorized craft access at Island View and Saanichton Bay Park.
- 3. Work towards completing waterfront walkways in Brentwood and Saanichton Bay, identifying priority properties for acquisition.
- 4. Improve viewing areas with better seating.
- 5. Install portable washrooms at popular shoreline access points.
- 6. Add educational signage.



Supporting Park Users

Develop signage and amenities to help mitigate conflicts between park users including developing designated fenced off leash dog areas.







- 1. Actively consider the needs and preferences of various user groups in park design.
- 2. Explore designating multi-use trails within parks where e-bikes and light electric vehicles (e-scooters, electric skateboards, etc.) are permitted and prohibiting use on pedestrian-only trails or areas with sensitive ecosystems to minimize conflicts.
- 3. Develop a Dogs in Parks program that has a primary focus on education and etiquette through signage and other programming.
- 4. Develop fenced off-leash dog parks within the District, including small dog parks near village centres. New proposed dog parks are in addition to the current off leash, under control regulations in most Central Saanich parks.
- 5. Update the Animal Control Bylaw to allow on-leash dogs only in Nature Parks with the secondary classification of Habitat/Conservation (Oak Haven, Gore and if developed in future, Amwell and Cooperidge Parks) to help protect the sensitive ecosystems.
- 6. Update the Animal Control Bylaw to allow on-leash dogs only in HEL,HILE ⊄ due the the significant plantings and the number of community events hosted in the Park.
- 7. Ensure equestrian friendly trails connect to existing trail networks to create a more extensive and accessible riding experience and work with the equestrian community on service delivery.
- 8. Provide amenities for equestrians in key locations. Including:
 - Horse-friendly parking and staging areas
 - Mounting blocks
 - Water troughs
 - Tie-up stations



Environmental Protection

Celebrate, protect and enhance our natural character and environment.



Proposed Actions

- 1. Formalize trail networks in conservation parks, adding fencing and signage to protect ecosystems.
- 2. Use native plants to support biodiversity and reduce irrigation.
- 3. Expand tree canopy in areas with limited coverage, including Keating Business District, and ensure shade trees near playgrounds and park amenities.
- 4. Add shrubs and pollinator plantings for species diversity.
- 5. Develop an invasive species management plan for key parks like Butterfield Park.
- 6. Consider wildfire risk and FireSmart principles in parks and shoreline areas.
- 7. Promote Green Shores solutions for shoreline protection and enhance natural buffers against sea level rise.

Guiding Future Park Land Acquisition

Ensuring future parks respond effectively to community needs and priorities.



Proposed Priorities

- Target active parkland within a fiveminute walk of residences in the Urban Containment Boundary.
- 2. Expand existing parks
- 3. Create linear parks that prioritize trail connections between different amenities, schools, and village centres.
- 4. Protect Natural areas and special features including sensitive ecosystems, archaeological sites, and heritage features.
- 5. Provide space for needed recreational amenities and sporting facilities

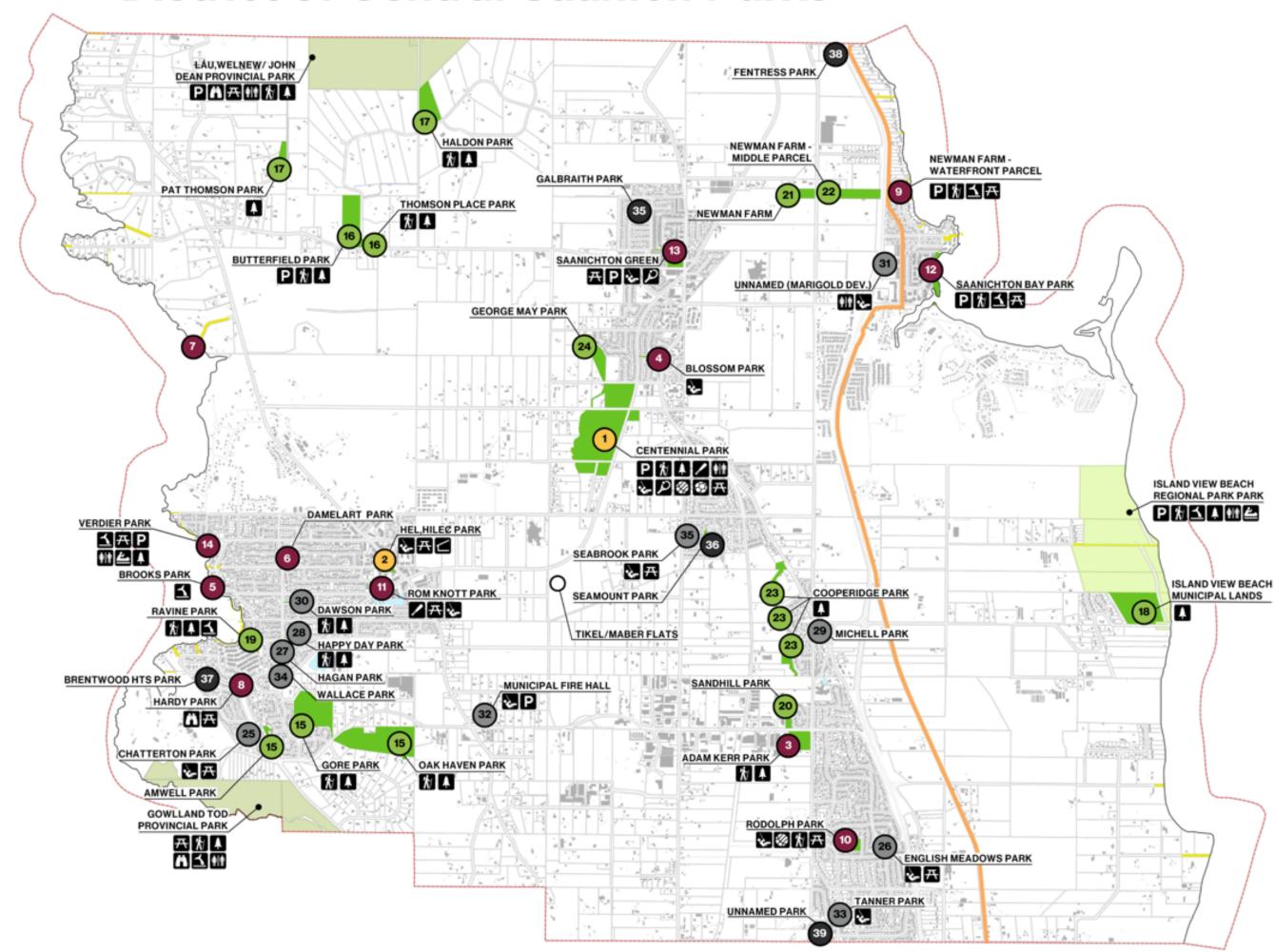

- Seek additional land acquisitions to extend the waterfront walkway.

DAMELART PARK

- Consider future acquisition opportunities to create a pathway connection to the park from the south side (Clarke Road) and west.
- Maintain as an open area with native plantings

HAGAN BIGHT - KENNES VIEWPOINT

- Develop a fenced dog off-leash area in the grass area alongside the pathway.
- Maintain views and easy access to the bench closest to the shoreline.
- Make trail improvements to accommodate park visitors with mobility challenges.
- Consider constructing stairs to improve shoreline access.
- Engage with the Tsartlip First Nation to explore opportunities for collaboration

8 HARDY PARK

Consider a dedicated fenced off-leash dog area.

NEWMAN FARM - WATERFRONT PARCEL

- Consider a Park Improvement Plan that is in keeping with the Newman Farm Master Plan.
- Engage with the Tsawout First Nation to explore opportunities for collaboration
- Install interpretive signage to enhance visitor experience.
- Relocate boat houses to the top of the bluff and establish an interpretive attraction or consider structural improvements in the existing location to maintain their integrity.
- Replace stairs as a high priority due to their age.
- Improve access to the waterfront and beach.

10

RODOLPH PARK

- Consider adding a washroom facility.
- Explore the possibility of a bike pump track, volleyball area, or other youth amenities.

11

ROM KNOTT PARK

- Consider creating contiguous parkland with HEL, HILE¢ to enhance ecological connectivity and park space continuity.
- Construct better storage facilities and a pitching warm-up area for the ball diamond.

12

SAANICHTON BAY PARK

- Consider adding a washroom, add more garbage bins and a picnic bench.
- Consider parking when conducting park improvements
- Improve pathways within the park, including accessible shoreline connections.
- Create additional viewing areas along the pathway.
- Enhance non-motorized small craft access
- Engage with the Tsawout First Nation to explore opportunities for collaboration, particularly regarding the small triangle of parkland south of the estuary.

13

SAANICHTON GREEN PARK

- Consider parking when conducting park improvements.
- Expand play facilities to include natural elements and wild play components.
- Consider adding an amenity for youth.
- Explore the creation of a small dog off-leash area.

14

VERDIER PARK

 Conduct an accessibility audit to determine if improvements to the shoreline access are feasible.



DRAFT PARK SPECIFIC ACTIONS Nature Parks



AMWELL, GORE, & OAK HAVEN PARK

- Consider providing additional access through undeveloped ROWs.
- Include fencing that jogs in and out to enhance user experience while protecting sensitive ecosystems from trail users.
- Consider updating the Animal Control Bylaw to allow for on-leash dogs only.
- Develop a park management plan for Amwell, Gore, and Oak Haven Parks, including:
- Manage for invasive species.
- Exploring a potential partnership with Habitat Acquisition Trust for Gore Park and Amwell Park, similar to the existing covenant for Oak Haven Park.

16

BUTTERFIELD, THOMSON & NEW PARKLAND

- Manage parkland jointly and consider renaming as one park.
- Improve Park entry and wayfinding, including parking and signage.
- Improve trail accessibility
- Develop equestrian trail connections

17

HALDON & PAT THOMSON PARK

- Discuss potential landownership with BC Parks or the BC Parks Foundation for the future inclusion as part of ŁÁU,WELNEW/John Dean Provincial Park.
- Consider re-routing Thunderbird Trail to improve trail sustainability and user experience.

18

ISLAND VIEW BEACH MUNICIPAL LANDS

- Repair the existing concrete ramp to provide seasonal non-motorized small craft launch (kayaks, canoes, dinghies, etc.).
- Consider working with CRD Tsawout and other groups.
- Update the main parking lot to clarify parking spaces.
- Improve accessible access to the beach.

19

RAVINE PARK

- Create an accessible lower trail connecting Anchorage and Port Royale waterfront pathways.
- Conduct trail and bridge rehabilitation in other areas of the park.

- Consider land acquisitions in the area to create connectivity with Adam Kerr Park and Cooperidge Park.

22

NEWMAN FARM PARK - MIDDLE PARCEL

- Consider partnerships for food security, food hubs, and/or food forests.
- Explore opportunities for animal husbandry and the potential for a future riding ring hosted by an equestrian society, similar to the Elk/Beaver Lake facility.
- Consider creating an interpretive trail as part of the park improvements.
- Ensure improvements align with the agricultural and ecological goals of the Newman Farm Master Plan.

COOPERRIDGE PARK

- Conduct feasibility studies for trail access.
- Continue to acquire land to protect additional sections of Tetayut Creek.

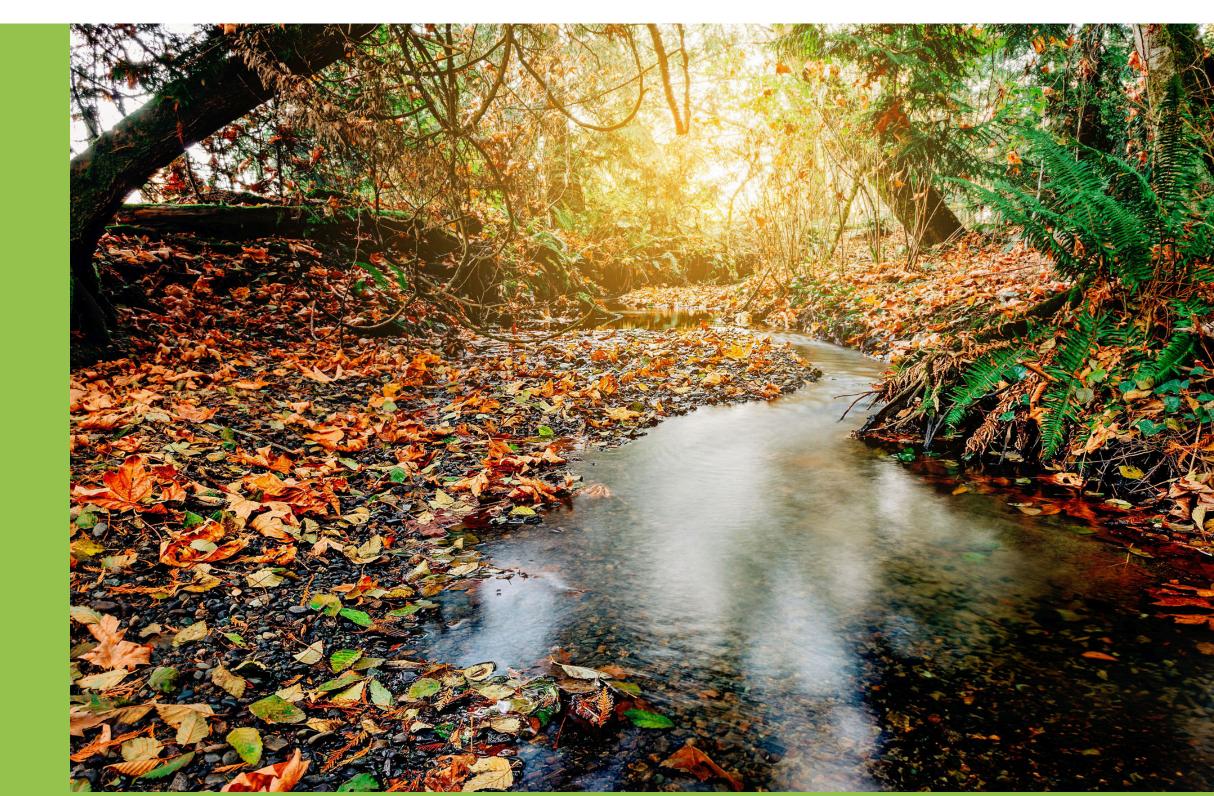

Making the plan a reality

There are several ways to bring these proposed park improvements to life. Currently, funding comes from a combination of taxes and community amenity contributions.

Corporate sponsorship agreements

A revenue strategy to help pay for amenities in exchange for corporate recognition and/or naming rights.



Grants

Many organizations and other levels of government provide partial or complete funding for park amenities, such as accessible washrooms.

Donations & Legacy

Individuals can leave land (such as Newman Farm Park) or money to the District.

Property sale

The District can sell unusable or surplus parkland to fund other parkland purchases.

Amenity Cost Charges

A new tool local governments can use to collect fees from new developments to help finance amenities such as parks that need additional support from the population growth of the new development.

Land negotiations as part of development

Partnerships

Working with other governments and organizations to fund new amenities, or share facilities and costs.



Next Steps

Engagement will confirm actions and identify priorities that will be used to develop the implementation framework and budgeting.
